For several years now the National Geodetic Survey has provided users survey grade single point GPS positions through the use of the Online Positioning User Service or OPUS. OPUS-Projects is an extension of that online service to provide the user with the knowledge and capability to complete an entire GPS campaign or project on line from downloading the data to least squares adjustment. Access to OPUS-Projects is restricted to individuals who have successfully completed training and this course will provide the attendee with that training. This is a hands-on seminar and for this training you will need:

- 1. A computer with wireless internet access capability (internet access will be provided).
- 2. Should be able to access your email from the training location. For the best class experience, it is advised that access to your email should be through your computer and not on a smart phone.
 - * Note: The email address you provide in registering for this class is important because that address is what will be registered in the NGS database for your future use of OPUS Projects.
- 3. Pre-established project and project data (training data & individual projects will be provided, but you may also bring your own data if you like).

What is OPUS Projects?

OPUS-Projects is a web-based utility that provides access to the National Geodetic Survey's (NGS) precise GPS positioning software for processing and adjusting survey projects spanning multiple observing sessions. It provides geodetic network solutions utilizing baseline processing of project sessions comprised of simultaneous GPS observations followed by a least squares adjustment of all project sessions. OPUS-Projects begins by creating a network project on the OPUS-Projects home page. Next, data is uploaded through the standard OPUS web page with the project Key Word generated at project creation. Project managers receive copies of the OPUS reports and can monitor project performance and progress via maps and tabular formats as the project is taking place. Once a project's data has been uploaded, session processing provides options for designing baseline connections and mark constraints. The position solutions from each session may be viewed and evaluated graphically prior to the final network adjustment.

Step 1: Creating a Project

You'll need your email, the project title, type, approximate location, starting date, & size.

- Navigating to the OPUS-Projects gateway.
- The project creation confirmation.
- Setting the preferences
 - Navigating to the preferences form.
 - o Changing the project title, ID or keywords.
 - Setting the solution quality thresholds.
 - Setting the data processing defaults.
 - o Changing the session definition.
 - o Changing the mark co-location definition.

Step 2: Uploading Data

You'll need any valid email address, a data file, the antenna type, height, & project ID.

- Uploading a project data file to OPUS.
 - o Entering a project ID in OPUS options.
 - o The upload confirmation page, Is this a new or recovered mark?
 - o The new mark description.
 - o The recovered mark description.
- What a field member would see after OPUS processing.
 - o The OPUS report.
 - o The OPUS-Projects solution quality report.

You'll need any valid email address, the project ID & session OR manager keyword.

 - Including or excluding marks.
 - Designating hub marks
 - Selecting the constraint type.

 - Processing Preferences.
 - The output reference frame.
 - The output geoid model.
 - The tropo model and interval.
 - The elevation cutoff.
 - The constraint weights.
 - Default network designs.
 - Submitting to the processing queue.
