#### Grants

The first item was the status of grants. Ms. Sonita Tiwari reported that there are four grants in work with the remaining to be done before the end of August 2008.

A FFO linked to the June Omnibus is scheduled to be out by 11 July 2008 (originally scheduled for release by 30 June). Check the NGS site and GRANTS.GOV for possible updates. A Letter of Intent (LOI) in response to the FFO must be submitted by 1 August. The final proposal under the FFO is due 2 September 2008 through GRANTS.GOV. Funding is for FY 2009.

It is possible to search the GRANTS.GOV website for height modernization funding opportunities by using the search tool on the site. The relevant search number is CSDA 11.400 NGS will review submitted LOIs and evaluate how proposed projects serve the NGS Height Modernization Program (HMP).

Renee stated that funding for HMP "FY 2009 not looking good...." No idea at this time of the budget amount.

# **Outreach, Education, Capacity Building**

## - Website

Vicki Veileux of NGS is updating the HMP web page. LA pages are being worked on. Problems related to the posting of the 2006 LA project to the NGS database are being resolved. The NGS database has been undergoing problems recently and crashed yesterday. It is back on line "new and improved" and restored from backups.

The new NGS Technical Memorandum dealing with orthometric height determination by GPS is undergoing high level review prior to official release. The review is at the NOS level.

Bill Henning RTN Lead mentioned his continuing efforts to meet with users and to participate in cooperative standards development. He is working with FIG among others.

# **Projects, Procedures, Software Developments**

NGS HQ staff are working to retrieve data for use in creating a new geoid model. This new model should be available before the end of the year. Unfortunately, OPUS-DB data will not be included. The Louisiana project mentioned above should; our TCOON project will not.

VDATUM efforts will shift to the Gulf Coast next. No date or specific locations were known. The possibility of a meeting to discuss how local agencies can help expedite the creation of the data sets needed for VDATUM was discussed with no decision.

The Corps of Engineers and NGS are discussing height validations. No details at this time.

FEMA and NGS are discussing height validation. No details at this time. Mr. Ronnie Taylor indicates that FEMA may consider funding level projects in the future (in a year of so). This is neither a definite decision nor a definite timeframe.
