Budget and Grant

- The Omnibus bill has passed but the divisions have not received their allocation. The budget has only the President's request for the Height Modernization Program and 3 or 4 earmarks which are classified as hard earmarks. "Soft earmarks" are identified by Congress in report language as something it would like to see awarded (therefore an "earmark") but haven't been listed in an actual appropriations law (therefore "soft"). NOAA is re-evaluating it's understanding of hard vs. soft earmarks and NGS is awaiting guidance.
- We received strong support from NOAA's Administrative Assistant, Jack Dunnigan, to get stimulus funding for the Height Modernization program. Unfortunately upper management in DOC/NOAA judged that the Height Modernization Program did not rank high enough to receive stimulus funding. The stimulus funding NOS receives will go to eliminate the hydrological survey backlog. NGS encourages the states to seek stimulus funding from other venues to maintain the momentum to modernize the height system. Some of the stimulus funding from other agencies may be distributed through Grants.gov.
- NGS has no funding for competitive grants as in previous years (in FY2008 we had almost \$2.5M for discretionary competitive Height Mod Grants). At present time, the only certainty is that the states with designated earmarks will receive funding.
