1. NGS/CO-OPS Project Activities

<u>Geoid Slope Validation Survey</u> in TX is complete, with the exception of some gravity data that needs to be finished. Height Mod will provide a little bit of funding to support the analysis and research that will come from the data collected. Also beginning to plan for the next similar effort in 2013. This year we will recon 2-3 locations to see where we might collect data that will expand our understanding through new challenges, e.g. the Pacific northwest or Colorado Rockies.

Several expanded leveling data adjustments are being done to contribute to GEOID12. These include a MSDOT leveling project running from Pensacola, FL to LA, leveling projects in Tennessee, and a readjustment of all the leveling collected in height mod projects across the state of Wisconsin. GPS projects supported by these leveled bench marks have already been incorporated into the NGS IDB to ensure that updated ellipsoid heights are computed from the NA2011 project, but the orthometric height adjustments for these projects will wait for GEOID12. These include MSDOT and southern Louisiana projects.

The Federal Register Notice defining the Virgin Islands vertical datum (VIVD) was published December 12.

CO-OPS is looking into establishing a Memorandum of Understanding with the National Park Service to be able to support them with water level installations in the various parks. The VDatum program is installing 9 water level stations in North Carolina, some of which are on NPS lands. The NPS contacted CO-OPS about the possibility of extending the 3 month VDatum installation to support their sea level rise work. Without an MOU in place CO-OPS we will not be able to support this. Once an MOU is in place CO-OPS will be able to work with the NPS to support their needs when a water level gauge installation for such items as Hydro survey, VDatum, Coastal, etc. coincides with a NPS requirements.

2. NGS Outreach/Education

Reminder that NGS will be holding the next geospatial summit at beginning of the Esri User Conference in July 2012 in San Diego, CA. Currently the summit is planned for the Sunday before the User Conference plenary – it will be a six hour meeting. On the Tuesday following the User Conference plenary, there will be a two hour special interest group (SIG) meeting. This summit will be a little different from federal geospatial summit in 2010; NGS is targeting the GIS community rather than other federal agencies. We are also expecting some attendees from the Survey Summit which precedes the Esri conference.

3. Updates from States – e.g. outreach, projects

<u>IL (Amy Eller)</u> – November 30, Illinois held interviews with 7 local firms to do 700 miles of leveling to begin in March.

<u>SC (Dick Woods)</u> – One height mod project was submitted to NGS last month, and they are currently doing recon for a 3-county height mod project. SC has a scanner ordered so all documents for future projects can be submitted to NGS digitally.

4. Monthly presentation

Analyzing the National Adjustment of 2011 using GIS Michael Dennis, National Geodetic Survey

Michael provided a status report on the National Adjustment of 2011 (NA2011) Project currently underway, including preliminary NA2011 results. Michael reported on the problems NGS is working on and demonstrated how GIS technology is being used for analysis and display of these results. Michael released some files to the advisors and coordinators to review and provide input on various problem areas. Q (Renee Shields) When will this be complete and published?

A There are a number of factors impacting the complete and published. A There are a number of factors impacting the completion of this project, for the most part involving decisions to be made on how to handle problem areas. It is hoped that the project will be delayed no further than one month beyond the original target date of the end of CY11. Dan Roman is also waiting for the results to use for GEOID12, which is also dependent on getting results from the special adjustments of leveling being done in MS, LA, TN, and WI.
