Ports of Wilmington and New Castle, Delaware and New Jersey

Introduction

NOAA Coastal Mapping Program (CMP) Project DE0901 provides a highly accurate database of new digital shoreline data for the ports of Wilmington and New Castle and vicinity, in Delaware and New Jersey. The Geographic Cell (GC) may be used in support of the NOAA Nautical Charting Program (NCP) as well as geographic information systems (GIS) for a variety of coastal zone management applications.

Project Design

The design of Project DE0901 was accomplished by the Requirements Branch (RB) of the Remote Sensing Division (RSD) in response to the need for updates to NOAA's Electronic Navigational Chart series. Project requirements were formulated as a result of analysis conducted within the Coast and Shoreline Change Analysis Program (CSCAP), in which NOAA nautical chart products are compared to contemporary high resolution imagery in order to ascertain the need for more current shoreline data. Refer to the updated CSCAP memorandum of August 10, 2009 for more details of the analysis.

Field Operations

Routine CMP field operations did not apply for this project based on the origin of the project imagery, which was obtained from external sources.

Georeferencing

One orthophoto mosaic from the National Agriculture Imagery Program (NAIP) utilized for CSCAP analysis was assessed for positional accuracy and determined to be suitable for feature compilation without the need for further image georeferencing tasks. Photo-identifiable check points from previously compiled GC10626 (CMP Project NJ0301D) and GC10627 (NJ0301E) were used for this assessment. A horizontal circular error of 1.6 meters was calculated based on a 95% confidence level. This CE value was doubled and added to the accuracy (CE95) of the source data from which check points were measured in order to conservatively predict the accuracy of well-defined points measured during the compilation process. See the Project Completion Reports for NJ0301D and NJ0301E for details on the source of the checkpoints used in this assessment, including the imagery and accuracy.

Compilation

Data compilation was performed by RSD personnel in December 2013. Digital feature data was compiled in shapefile format from the ortho imagery using Esri ArcGIS (ver. 9.3.1) desktop GIS software. Feature attribution was assigned in compliance with the

Coastal Cartographic Object Attribute Source Table (C-COAST), which provides the definition and attribution scheme for the full range of cartographic features pertinent to the CMP.

Spatial data accuracies for DE0901 were determined according to standard Federal Geographic Data Committee (FGDC) practices. Cartographic features were tested to have a horizontal accuracy of 3.9 meters at the 95% confidence level by comparing a minimum of twenty (20) check points to an independent source of higher accuracy.

Quality Control / Final Review

Quality control tasks were conducted upon project completion by senior CMP quality assurance personnel in January 2014. The review process included an assessment of the identification and attribution of digital feature data within the GC according to image analysis and criteria defined in C-COAST. The quality control process concluded with an inspection of topological connectivity within the GC using ArcGIS 9. The entire suite of project products was evaluated for compliance to CMP requirements.




