



- (b) T-2241 (1896) The shoreline has receded from 56-100 m. since 1896.

 Many inland details have remained unchanged.
- (c) T-2242 (1896) The shoreline has receded from 20-50 m.

 A few of the inland details have remained unchanged.

 The shoreline of Church Creek has changed very little.

 Many small changes due to erosion and accretion have altered the the shoreline which along most of its length is the boundary of marsh land.
- (d) T201 (1896) The general shape of the shoreline is unchanged but the shoreline along marshes has eroded as much as 100 m.

 Many inland details have changed. The land is now more developed.

JUNCTIONS:

This sheet joins T-5698 and T-5699 on the north;

T-5702 on the east; and T-5703 on the south.

T-5702 has not yet been detailed.

This sheet is believed to be complete in all detail of importance for charting and no additional surveys are required.

The probable error is not graeter than 5 meters for radial points (shown in violet on the back of this sheet) and well defined objects along the waterfront. The error of other detail is not greater than 10 meters.

1. The charts of this area have been examined and topographic information necessary to bring the charts up to date is shown on this compilation. (Par. 16a, b, #, d, e, g and i; 25; and 64)

- -2. Change in position, or non-existence of wharfs, lights, and other topographic detail of particular importance to navigation which affect the chart, is discussed in the descriptive report. (Par. 26; and 66 g,n)
 - 3. Ground surveys by plane table, sextant, or theodolite have been used to supplement the photographic plot where necessary to obtain complete information, and all such surveys are discussed in the descriptive report. (Par. 65; and 66 d,e)
 - 4. Blue-prints and maps from other sources which were transmitted by the field party contain sufficient control for their application to the charts. (Par. 28)
 - Differences between this compilation and contemporary plane table and hydrographic surveys have been examined and rectified in the field before forwarding the compilations to the office and are discussed in the descriptive report.

- 6. The control and adjustment of the photo plot are discussed in the descriptive report. Unusual or large adjustments are discussed in detail and limits of the area affected are stated. (Par. 12b; 44; and 66 c,4/4)
- //. High water line on marshy and mangrove coast is clear and adequate for chart compilation. (Par. 16a, 43, and 44)

NOTE: Strike out paragraphs, words or phrases not applicable and modify those requiring it. Paragraph numbers refer to those in the Topographic Manual. Refer also to the pamphlet "Notes on the Compilation of Planimetric Line Maps from Five Lens Air Photographs."

- The representation of low water lines, reefs, coral reefs and rocks, and legends pertaining to them is satisfactory. (Par. 36, 37, 38, 39, 40, 41)
- Recoverable objects have been located and described on Form 524 in accordance with circular 30, 1933, circular letter of March 3, 1933, and circular 31, 1934. (Par. 29, 30, and 57)
- 10. A list of landmarks was furnished on Form 567 and instructions in the Director's letter of July 16, 1934, Landmarks for Charts, complied with. (Par. 16d, e; and 60)
- All bridges shown on the compilation are accompanied by a note stating whether fixed or draw, clearance, and width of draw if a draw bridge. Additional information of importance to navigation is given in the descriptive report. (Par. 16c)
- 12. Geographic names are shown on the overlay tracing. The accepted local usage of new names has been determined and they are listed in the report, together with a general statement as to source of information and a specific statement when advisable. Complete discussion of place names differing from the charts and from the U.S.G.S. Quadrangles is given in the descriptive report, together with reasons for recommendations made. (Par. 64, and 48%)
- 13. The geographic datum of the compilation is NA 1927 and the reference station is correctly noted.
- 14. Junctions with adjoining compilations have been examined and are in agreement. (Par. 66j)
- 15. The drafting is satisfactory and particular attention has been given the following:
 - 1. Standard symbols authorized by the Board of Surveys and Maps have been used throughout except as noted in the report.
 - 2. The degrees and minutes of Latitude and Longitude are correctly marked.

- 3. All station points are exactly marked by fine black dots.
- 4. Closely spaced lines are drawn sharp and clear for printing.
- 5. Topographic symbols for similar features are of uniform weight.
- 6. All drawing has been retouched where partially rubbed off.
- 7. Buildings are drawn with clear straight lines and square corners where such is the case on the ground.

REVIEW OF AIR PHOTOGRAPHIC SURVEY T-5701

There are no contemporary graphic control surveys in this area.

Hydrographic Surveys

The 1940 hydrographic survey of the Chester River has not yet been received in the office.

Comparison with Hydrographic Surveys



T-199, 1:20,000, 1854, covers the Chesapeake Bay shoreline from Huntingfield Creek south to Chester River. Comparison with T-5701 shows that the cliff between Lat. 39° 06' and Lat. 39° 07' has washed back 180 meters since 1854 and that south of Lat. 39° 06' has washed back about 35 meters.

T-201, 1:20,000, 1846, covers lower Chester River and its tributaries. The general shape of the shoreline has changed little, but there have been changes up to 100 meters where marsh has been cut away.

T-5701 supersedes all of the above previous surveys for charting purposes, except for contour lines on T-2291, T-2241, and T-2242.

Charts 77, 1226, 548, 549

Chart 548, 1:40,000 (printed May 15, 1941)

The Chesapeake Bay shoreline from Huntingfield Creek to Chester River has washed back from 30 meters to a maximum of 110 meters since the survey upon which the chart was based. It also appears that the stone jetties at Lat. 39° 05.5' are of different appearance than is shown on the chart.

Minor changes in shoreline have occurred along Chester River and its tributaries. The largest shoreline change is in the marsh between Church Creek and Chester River at Lat. 39° 04'; the width of the marsh at this point has been reduced by about 150 meters, 110 meters being from the Chester River side. Several old piers or wharves are now in a state of ruin and several new piers have been built. The 1940 hydrographic survey of Chester River should show whether the old piers are entirely gone or whether some piles still remain.

Chart 549, 1:40,000 (printed May 22, 1941)

The first paragraph under the comparison of Chart 548 and T-5701 also applies to 549. In addition, the numerous orchards shown on 549 are now largely gone.

T-5701 was reported as having been applied to chart drawing 548 in October 1940 and to chart drawing 549 in May 1941. During the review of T-5701 July 1941, the details of the marsh line of the small creek at Lat. 39° 05'. Long. 76° 07.8' were changed slightly.

NOTE:

T-5701 was compiled in 1940 and reviewed in 1941, but processing in the Washington Office was not completed until July 1946 because of war map work of the Bureau. Meanwhile, the Coast and Geodetic Survey produced topographic quadrangles (manuscript scale 1:20,000) for the War Department of this same area. Planimetric details from T-5701 were used as a base in preparing quadrangle T-5273, which was completed in 1943. This quadrangle is more recent and more complete as regards map details than T-5701, but is at a smaller scale.

Charts 1226 and 77

In general, the discussion under chart 548 above also applies to charts 1226 and 77 which are on greatly reduced scales.

Radial Plot

A description of the radial plot is given in the Descriptive Report accompanying T-5498. Sheets T-5692, T-5695, T-5698, T-5701, and T-5702 were plotted as a unit, being the first plot undertaken by the field party in Baltimore. There is excellent control on T-5701 and the main radial plot is very good.

Field Inspection and Detailing

The field inspection is complete and the detailing on T-5701 is sufficient on the rough drawing to enable completion of the final smooth sheet or blue line.

Junctions

The junctions with T-5703, T-5698, and T-5699 were checked and found in agreement. Sheet T-5702 has not been received in the office and hence could not be checked at this time.
